### DECLARES UNDER THEIR OWN RESPONSIBILITY,

as a candidate;  as university staff.

to have read the safety and health protection measures in the dedicated section of the institutional website of the universities and to adopt, during the competition test, all the containment measures necessary to prevent the contagion from COVID-19.

not to be subjected to the measure of quarantine or trustee home isolation and / or the prohibition of removal from one's home / home provided as measures to prevent the spread of the COVID-19 contagion pursuant to current legislation.

not having or having had symptoms (e.g., fever, sore throat, cold, nausea, chills, headache, cough, diarrhea, vomiting) attributable to COVID-19 in the previous 14 days.

to have been symptomatic positive for COVID-19 and to have observed an isolation period of at least 10 days from the onset of symptoms (not considering anosmia and ageusia / dysgeusia - loss or alteration of taste and smell - which may have prolonged persistence over time) accompanied by a molecular test with negative result, performed after at least 3 days without symptoms.

to have been asymptomatic positive for COVID-19 and to have observed an isolation period of at least 10 days from the onset of positivity, at the end of which a molecular test is performed with a negative result.

In the case of close contact with COVID-19 positive people:

to have observed a mandatory quarantine period of 14 days from the last exposure to the case.

- to have observed a quarantine period of 10 days from the last exposure with a negative antigen or molecular test, carried out on the tenth day.
- that I have not been in contact with Covid-19 positive people, to the best of their knowledge, in the last 14 days.

### **The candidate also declares:**

- to have performed a rapid antigen or molecular test, carried out by means of a gold / rhino-pharyngeal swab at an accredited / authorized public or private facility, on a date not earlier than 48 hours from today's date, for which the green certification is hereby produced.

*Or*

- to have completed the vaccination procedure (double dose) for COVID 19, for which the green certification is hereby produced.
- to have received the first dose or single dose of vaccine for COVID 19 at least 15 days ago, for which the green certification is hereby produced.
- has been cured of Covid 19 for which the green certification is hereby produced.

This self-declaration is provided as a preventive measure related to the pandemic emergency of COVID-19. It, together with the attachments exhibited (report of the rapid antigen or molecular test or certificate of vaccination course, certificate of recovery from Covid), is an indispensable condition for participation in this public exam.
