

CALL FOR APPLICATIONS FOR ADMISSION TO THE THREE-YEAR DEGREE COURSE IN NURSING (IN ENGLISH LANGUAGE) A.Y. 2021/2022

ART. 1 - INDITION AND PLACES SUBMITTED TO COMPETITION.

The competition, by examination, for admission to the three-year degree course in Nursing, established and activated at the University of Campania "Luigi Vanvitelli", for the A.Y. 2021/2022, for a total number of places equal to 20 (twenty), divided as follows:

- n. 10 places reserved for non-EU students residing abroad;
- n. 10 places intended exclusively for EU citizens and non-EU citizens referred to in art. 39 co. 5 of Legislative Decree no. 286/1998, as amended by art. 26 of Law no. 189 of 2002.

ART. 2 - REQUIREMENTS FOR ADMISSION.

They can apply for participation in the competition - for access to n. 10 places referred to in the previous article, EU candidates and non-EU candidates residing in Italy, as referred to in art. 26 of Law no. 189 of 2002 mentioned in the introduction, in possession of a secondary education diploma of at least four years, or equivalent qualification, as well as all those who will achieve said high school diploma within the school year 2020/2021.

Only non-EU citizens residing abroad who have observed the inter-ministerial provisions relating to the procedures for the entry, stay and registration of foreign / international students to courses can participate in the selection for the 10 places referred to in the previous article. of higher education in Italy, for the A.A. 2021/2022, published on the MUR website by consulting, in particular, the information contained in the circular available at the web address https://www.studiare-in-italia.it/studentistranieri/moduli/2021/Circolare 2021 2022.pdf.

ART. 3 - METHOD OF PARTICIPATION IN THE COMPETITION.

1. To be admitted to the competition, candidates who compete for the 10 (ten) places intended exclusively for EU citizens and non-EU citizens referred to in art. 39 co. 5 of Legislative Decree no. 286/1998, as amended by art. 26 of Law no. 189 of 2002, they must submit an application to participate, using the credentials for accessing the University web services, exclusively through an IT procedure (website www.unicampania.it - Student Services> Online Competitions - click on> Access the service), to starting from 16/07/2021 and no later than 26/08/2021.

In this regard, a special guide is available for online registration for competitions for access to limited number courses (without options) published in the Online Competitions section of the University website to support users in the registration phases. necessary for the creation of the aforementioned Payment Notice Pago-PA.

For users who do not have the credentials, it is necessary to acquire them through the registration procedure described in the "Guide for new user registration".

To participate in the competition, candidates are required, under penalty of exclusion, to pay a contribution of € 100.00 to be made - following the creation of the Pago-PA Notice in the IT procedure - by 26/08/2021.

This payment can be made through both physical and online channels of banks and other Payment Service Providers (PSP), such as bank agencies, home banking, ATMs, SISAL, Lottomatica and Banca 5 points of sale, using the Pago-PA Payment Notice, which will be generated as part of the aforementioned IT procedure for registering for the competition.

¹ Foreigners holding a residence card or residence permit for subordinate work or self-employment, for family reasons, for political asylum, for humanitarian asylum, or for religious reasons, or foreigners legally residing for at least one year in possession of a qualification high school diploma obtained in Italy, as well as foreigners, wherever resident, who are holders of final diplomas from Italian schools abroad or from foreign or international schools, operating in Italy or abroad, subject to bilateral agreements or special regulations for recognition of academic qualifications and that meet the general conditions required for entry for study.



The IT procedure for submitting applications will be deactivated, strictly and automatically, on 26/08/2021 and, therefore, after this deadline it will no longer be possible to fill in the application for participation in the competition and generate the Notice of payment Pago PA bank to be used for the payment of the contribution for participation in the competition.

Registration for the competition is to be considered concluded only after payment of the aforementioned contribution has been made, within the terms and in the manner indicated above.

This payment will in no case be refunded and is valid exclusively for the competition for which the application form is being submitted.

The application submission procedure can be carried out - 24 hours a day - from any computer connected to the network.

Failure to submit the application within the aforementioned terms and in the manner indicated precludes any possibility of access to the competition.

The Administration, at each stage of the procedure, reserves the right to ascertain the truthfulness of the substitutive declarations of certification or deeds of notoriety made by the candidates, in accordance with current legislation on the subject; the candidate, therefore, must provide all the necessary elements to allow the Administration to carry out the appropriate checks.

- 2. Non-EU citizens residing abroad, who compete for the 10 reserved places (they do not have to submit an application to participate in the competition according to the procedures described above, but are admitted to the selection test only by observing the interministerial provisions for entry procedures, residence and enrollment of foreign students in higher education courses in Italy, for the A.Y. 2021/2022, published on the MUR website at https://www.studiare-in-italia.it/studentistranieri/moduli/2021/Circolare 2021 2022.pdf.
- **3.** The candidates referred to in this paragraph, who compete for the 10 (ten) reserved places, no later than August 31, 2021, are required to send an email to: <u>professionisanitarie@unicampania.it</u> to obtain the receipt / application of participation in the selective test and the payment notice Pago-PA to make the payment of € 100.00 (one hundred) as a contribution for participation in the competition.

The University offices are closed from 09 August to 22 August 2021.

3. The Administration, at each stage of the procedure, reserves the right to ascertain the truthfulness of the substitute declarations of certification or notarial deeds made by the candidates, in accordance with current legislation on the subject; the candidate, therefore, must provide all the necessary elements to allow the Administration to carry out the appropriate checks.

All candidates are admitted with reserve to the procedure set out in this notice of competition.

The Administration, with a reasoned decree, may proceed, at any time, to the exclusion of the candidate from the competition for lack of the prescribed requirements.

ART. 4 - ADMISSION TEST: DATE AND PLACE.

1. The admission test to the three-year Degree Course in Nursing (Nursing in English) is set for 14 September 2021, starting at 13.00, and a time of 100.00 is assigned for its development (one hundred) minutes.

The venue for the competition test will be announced with a subsequent notice, published on the University website, at the address www.unicampania.it.

By virtue of the provisions of Annex no. 1 of the D.M. of 25 June 2021 n. 730, the participants in the competition test will be distributed by age, except for twins.

- **4.** Candidates must present themselves at the venue for the competition test at 11.00 am, with a valid identification document, the receipt of the application form and the original receipt of payment of the participation fee, to be shown in order to complete the necessary identification procedure.
- **5.** In consideration of the ministerial provisions aimed at containing the epidemiological emergency from Covid -19, the adoption of organizational prevention and protection measures will be ensured.
- **6.** Candidates without an identification document will not be admitted to participate in the competition test, unless they are presented with a regular report of loss or theft produced to the competent authorities.



- 7. Candidates without the receipt of the submission of the application for registration, or the original receipt of payment of the participation fee, will not be admitted to take the test unless they are present in the lists of those entitled, prepared by the University.
- **8.** Access to the test is not permitted for candidates who present themselves after the closure of the recognition operations.
- **9.** Candidates who, for any reason, are absent from the test, after the closure of the aforementioned recognition operations, are considered to have renounced participation in the competition referred to in this announcement.

So much so, it has the value of notification to the interested parties.

ART. 5 - ADMISSION TEST: CONTENTS - CRITERIA FOR EVALUATION - TIME ALLOCATED FOR PERFORMANCE.

- 1. The admission test, which is attended by both EU and non-EU students pursuant to art. 26 of Law no. 189 of 2002, both non-EU citizens residing abroad, is unique and will be prepared by CINECA on behalf of the University. The aforementioned test consists in the solution of n. 60 questions in English with five answer options, of which the candidate must identify only one, discarding the wrong conclusions, arbitrary or less probable, on the following topics: general knowledge (12 questions), logical reasoning (no. 10 questions), biology (18 questions), chemistry (12 questions), physics and mathematics (8 questions), based on the program referred to in Annex "A" of the Ministerial Decree of 25 June 2021 no. 730
- **2.** For the evaluation of the admission test, a maximum of 90 (ninety) points are awarded and the following evaluation criteria are taken into account:
 - a) 1.5 points for each correct answer;
 - **b)** minus 0.4 (- 0.4) points for each wrong answer;
 - c) 0 points for each answer not given.

In the event of a tie, the following criteria apply:

- the score obtained by the candidate in the solution, respectively, of the questions relating to the topics of logical reasoning and general culture, biology, chemistry, physics and mathematics, prevails, in descending order.
- In the event of a tie between one or more disabled candidates in possession of a certificate of disability equal to or greater than 66% or disabled with certification pursuant to law no. 104 of 1992 art. 3, paragraph 3, and one or more candidates not falling within the aforementioned categories, the invalid candidate (s) in possession of a certificate of invalidity equal to or greater than 66% or disabled with certification pursuant to law no. 104 of 1992 art. 3, paragraph 3.
 - In the event of further equality, the candidate who is younger by birth prevails.

A time of 100 (one hundred) minutes is assigned for the performance of the test.

The admission test will also be completed if the number of applications presented is equal to or less than the number of places available.

ART. 6 - PROVA DI AMMISSIONE: MODALITA' DI SVOLGIMENTO - OBBLIGHI DEI CANDIDATI - VIGILANZA.

1. At the time of the test, each candidate is given an envelope prepared by CINECA on behalf of the University.

Each package contains:

- a) a personal data sheet, without any identification code, which the candidate must fill in;
- **b)** the questions relating to the admission test, bearing the identification code of the package as well as n. 2 sheets dedicated to draft;
 - c) a reply form, with the same identification code as the package;
- **d)** a sheet on which the identification code of the package is affixed as well as the indication of the University and the degree course to which the test refers;



- **e)** a sheet containing the anonymous credentials (User-ID and Password) through which the Candidate, after correcting the test, will be able to access a web page corresponding to a URL (also present on the sheet) where he can view:
 - 1. his proof, in html format, with an indication of the correct answers he should have provided;
 - 2. the score obtained;
 - **3.** the scan of your reply form.

The replacement that may become necessary during the test of the personal data sheet only, referred to in the previous letter a), does not involve the complete replacement of the envelope.

The replacement that may become necessary during the test of even one of the documents indicated in points b), c) and e) entails the complete replacement of the package as these documents are marked by the same identification code as the package.

Any corrections or signs made by the candidate on the personal data sheet do not entail its replacement. The replacement of the personal data sheet is provided only where the signs or corrections made by the candidate involve an objective difficulty in identifying the candidate: in that case the Commission will replace the personal data sheet by taking it from one of the reserve packages and the operation will acknowledge in the classroom minutes. In any case, the replacement of the personal data sheet never entails the replacement of the entire envelope.

Before the test begins, the President of the Examination Commission or the Classroom Manager draws four students from among the candidates present in the classroom and checks with them the integrity of the boxes, then opens them and distributes the packages in relation to the number of participants; gives each candidate the "instruction sheet for completing the answer form". The "instruction sheets for completing the answer form" are made available to candidates before the test is carried out.

The President of the Examination Committee or the Head of the classroom draws up and signs, for the operations carried out above, a specific declaration - CLASSROOM MINUTES - which show:

- 1.1) the verification of the integrity of the boxes;
- 1.2) the number of packages assigned;
- 1.3) the number of packages that may not have been used;
- **1.4)** the number of packages possibly replaced, with the relative motivation.

This declaration must also be signed by the four students drawn for the verification of the integrity of the packages containing the competition material.

On the day of the exam, the President of the Commission or the Head of the classroom also draws up the minutes of the classroom, prepared according to the format made available by the M.U.R.

In the event that one or more candidates report any irregularities regarding the package received, the President of the Examination Commission or the Head of the classroom checks its reliability and, if necessary, replaces the package itself. This operation must appear in the classroom minutes together with the relative reasons. The replaced packages are not to be considered waste material, but must be kept by the University.

Candidates, to fill in the answer form, must use only an indelible black pen, supplied by this University and must mark the chosen answer by putting the X sign in the corresponding box. It is possible to correct once and only once the answer already given to a question, taking care to completely black out the box previously drawn and choosing another one: in any case, there must be a mark (X) in only one of the five boxes so that the relative score can be attributed, otherwise no answer is deemed to have been given.

The answer form provides, in correspondence with the progressive number of each question, a small circular figure that the student must cross only if he intends to give certainty of the will not to answer. This indication, once affixed, can no longer be modified; if the candidate does not put any sign in the answer boxes, even if he does not tick the circular figure, the answer is considered not given.

On the answer form - for the purpose of determining the relative score - there must be no signature or any identification mark, under penalty of cancellation of the test.

At the end of the test, the candidate goes to the dedicated station equipped with a special pen, placed at a reasonable distance from the Commission, and is invited to choose a pair of identical adhesive labels present there. Each label must be applied on the answer form and on the personal data sheet by the candidate who must ensure that the alphanumeric codes printed on the labels of the chosen



pair correspond. The candidate must therefore obligatorily sign, on the duly completed personal data sheet, the declaration of truthfulness of the personal data and correspondence of the codes of the labels applied to the personal data sheet and to the answer form. At the end of these operations, the candidate must insert the personal data sheet in the sealed container present in the dedicated station and go to another dedicated station where he inserts the answer form in the closed container provided therein, taking care to insert the front of the form, containing the answers provided by the candidate, face down.

In addition to the answer form and the personal data sheet, the candidate must return to the Commission all the residual material contained in the package delivered at the beginning of the test.

The President of the Commission or the Head of the classroom then provides:

- to count the answer forms and to insert them in one or more containers that must be closed in the presence of the same candidates called to verify the integrity of the boxes or, in the event of their impossibility, in the presence of four other candidates drawn by lot;
- to insert all the personal data sheets in one or more containers that must be closed in the presence of the same candidates called to verify the integrity of the boxes or, in the event of their impossibility, in the presence of four other candidates drawn by lot;
- to affix a signature on the closing flaps of the containers and to invite the four students to put their signature on the same flaps;
- to pack other containers in which to enclose the packages returned because they have been replaced, the packages from which the personal data sheets for replacement have been taken as well as the unused packages, the declaration referred to in this article and a copy of the classroom minutes, with the classroom lists of candidates.
- 2. Candidates are prohibited from keeping with them, during the tests, bags or backpacks, books or notes, paper, personal tools suitable for writing (pens, pencils, etc.), mobile phones, "smartphones" and other electronic tools, including "smartwatches", "PDAs", tablets, headsets, webcams and portable personal computers of any type able to connect outside the classrooms, test locations, via "wireless" connections, or to the normal telephone network with UMTS, GPRS, GSM protocols, under penalty of cancellation of the test. Therefore, candidates are prohibited from introducing within the competition venue: mobile phones, smartphones, smartwatches, PDAs, tablets, headsets, webcams and other similar tools; candidates, who are in possession of such equipment, must deliver them to the identification staff before entering the classroom or sector where the candidate was assigned to perform the test.

It is also forbidden to introduce manuals, school texts, handwritten notes and reference material and blank sheets. During the test, competitors are not allowed to communicate verbally or in writing, or to get in touch with others, except with the members of the Commission or the Supervisory Committee or with the technical-administrative staff responsible for surveillance.

The candidate who infringes the provisions of this article is canceled by the Commission and the same is excluded from the competition.

3. Any further information on how to conduct the test and time spent in the classroom will be disclosed with a subsequent provision, or with the information provided in the classroom to the candidates by the Commission, following the indications provided with the guidelines by the M.U.R.

ART. 7 - CAUSES FOR CANCELLATION OF THE TEST.

The following are grounds for cancellation of the test:

- **1.** the performance of the test by the candidate in an exam room other than the one in whose classroom lists the candidate is enrolled unless the variation has been authorized by the Examination Commission and this is acknowledged in the minutes;
- **2.** the introduction and use in the classroom, by the candidate, of mobile phones, PDAs, smartphones, smartwatches, tablets, headsets, webcams or other similar equipment, manuals, school texts and / or even partial reproductions of them, handwritten notes and reference material, as already provided for in paragraph 2 of article 6 of this announcement;
- **3.** the affixing on the answer form (both on the front and on the back) of the signature or marks of the candidate or a member of the Commission:
- **4.** the interaction between candidates and / or attempts to copy and / or attempts to exchange any material, including the exchange of personal data and / or response forms, in the possession of the candidates:



5. the use by the candidate, during the operations of inserting the personal data sheet and the answer form inside the containers used therein, of pens, pencils or any other suitable instrument for writing in order to make changes, additions and / or corrections to the reply form.

The cancellation of the test is ordered by the Commission. In the cases referred to in numbers 1), 2), 3) 4) and 5) the CINECA does not determine the score of the canceled test.

The test is also subject to cancellation in case of use by the candidate, after the end of the test, of pens, pencils or any other suitable writing instrument in order to make changes, additions and / or corrections to the answer form, and in the event that the personal data sheet shows erasures and / or abrasions or indicates data which, at the discretion of the Commission, do not allow to trace the author of the paper with certainty.

ART. 8 - CRITERIA AND PROCEDURES FOR THE APPOINTMENT OF THE COMMISSION IN CHARGE OF THE ADMISSION TEST AND FOR THE APPOINTMENT OF THE PROCEDURE MANAGER.

The Commission in charge of the admission test, appointed with a subsequent provision, is composed of the President, a teacher with teaching activities in the study courses of the School of Medicine and Surgery and of 6 (six) effective members plus two alternates, appointed from among all the teachers and researchers with teaching activities in the study courses of the School of Medicine and Surgery. The Commission is given all responsibility for the regular performance of the test in question, according to the methods and criteria set out in this announcement and by the Ministerial Decree of the M.U.R. of 25 June 2021 n. 730 mentioned in the introduction. The commission in charge of the test is also responsible for the tasks that will be detailed in the appointment provision. All the operations carried out by the commission in charge of the test must be reported in a special report, initialed on each sheet and signed by the President and by all the members of the commission itself.

During the test, the aforementioned Commission is assisted in its tasks by a Supervisory Committee - also appointed with a subsequent provision - made up of teaching and / or research staff with teaching activities in the study courses of the School of Medicine and Surgery, with tasks of checking the regularity of the performance of the test and reporting any irregularities to the Commission, which will take the relevant decisions.

In its supervisory activity, the Commission will be supported not only by the aforementioned Supervisory Committee, but also by the University's technical-administrative staff in charge of this function, as well as by security guards.

Pursuant to art. 4 of the law n. 241 of 07/08/1990 and subsequent amendments (New rules on administrative procedure and right of access to administrative documents) and of the single regulation on transparency: discipline on administrative procedure and access (DR no. 622 of 26.07.2018) is appointed Head of the entire insolvency procedure, which does not fall within the competence of the Commission of selection, dott. Alfio FALANGA, administrative-managerial EP category, economic position EP1, in service at the Career Management and Student Services Department.

The members of the Commission and of the Supervisory Committee, the Head of the procedure and all the staff involved in any capacity in the supervisory operations, before carrying out the admission test referred to in this announcement, must, after consulting the printouts showing the names of the candidates admitted to participate in the competition, issue a declaration that they have no kinship or affinity relationship with any of them up to and including the fourth degree, that they do not hold political positions.

ART. 9 - RANKING.

Candidates are only eligible if they have achieved a score greater than zero (0) points.

Candidates who have not provided any answers to any question as required by art. 8 of the aforementioned Ministerial Decree 730/2021.

Based on the evaluation criteria referred to in art. 5 of this call for applications, the University draws up two distinct rankings, one for EU citizens wherever they reside and for non-EU citizens pursuant to art. 26 of Law 189/2002, and the other for non-EU citizens residing abroad.

In the respective rankings of merit the candidates placed in a useful position with respect to the number of places available will be the winners.



Candidates ranked in subsequent positions with respect to the places available for the competition are not entitled to enrollment, without prejudice to any changes in the ranking specified in the following art. 12.

ART. 10 - PUBLICATION OF RANKINGS.

The rankings referred to in the previous art. 9 will be published on the University website, at www.unicampania.it by 28 September 2021.

The publication has the value of official notification to interested parties for all legal purposes and, therefore, no communications and personal notifications will be sent to candidates.

ART. 11 - TERMS TO BE OBSERVED FOR ENROLLMENT.

1. Candidates who compete for the quota reserved for EU citizens and non-EU citizens resident in Italy, of which 39, paragraph 5, legislative decree 25 July 1998, n. 286, as amended by art. 26 of Law no. 189 of 2002 - taking into account the number of places in the competition referred to in art. 1 of this call for applications - must register and submit the enrollment application exclusively in the manner indicated below, starting from 04 October 2021 and no later than 12:00 on 13 October 2021.

Register and submit the enrollment application online, by accessing the student web services area (http://www.unicampania.it/index.php/2011-03-28-06-44-19/immatricolazione-on-line) with the credentials previously used, according to the procedures indicated in the Enrollment Guide (standard, shortened courses, renounced or lapsed in the previous university career or transferred on entry) to limited attendance courses or in the Guide for enrollment matriculation for transfer to a limited number study course, published at the aforementioned link in the student web services area, indicating the "Bachelor's Degree" Course Type and the B50 "Nursing (English language Nursing)" as the course of study.

During the ONLINE REGISTRATION procedure of the enrollment application it is necessary to upload the following documentation:

- · identity document (mandatory and blocking upload);
- tax code (mandatory and blocking upload);
- passport-size photo (at least 266x354 pixels) showing the face in the foreground (mandatory, non-blocking upload, to be done within 30 days of registering the application)

During the ONLINE SUBMISSION procedure of the enrollment application, it is necessary to upload the following documentation, in the user's web area in the "Career / Career Attachments" section:

- enrollment application previously registered, printed and signed (Type of Attachment: Enrollment application);
- receipt of payment of the first registration installment (Type of Annex: Receipt of payment of the first registration installment);

The application for enrollment will be considered duly submitted only in the event that, within the terms provided for the enrollment itself, they are present in the aforementioned IT procedure no. 4 upload - (identity document, tax code, signed enrollment application and receipt of payment of the first enrollment installment). Failure to comply with the foregoing will result in the loss of the right to enroll. The exact date and time of upload is recorded in the University database, therefore, uploads made after the indicated deadlines will not be valid for enrollment.

2. Starting from 04 October 2021 and no later than 12:00 on 13 October 2021, candidates who compete for the quota of places reserved for non-EU citizens residing abroad, entitled - taking into account the number of places in the competition - who intend to exercise the right to enroll, must submit, during the opening hours of the Student Secretariat Office of the Degree Courses of the Health Professions - Via L. Armanni n. 5 - 80138 Naples, enrollment application, duly completed in block letters, on the specific form available on the University website at the dedicated address http://www.unicampania.it/index.php/studenti/ammissioni-corsi-di-laurea, as well as the additional documents indicated in the same application form.

Those who intend to obtain an abbreviation of the course of study are required to produce, together with the enrollment application, the useful university documentation (certificate of exams obtained including grade and date of taking, credits for each exam as well as the university programs



adopted) for the purposes of evaluation that will be the responsibility of a special didactic commission appointed for this purpose. So much, in accordance with the current legislation on the matter.

Applications for registration or documentation sent by post, e.g. by mail, will not be accepted. or by fax.

Failure to register within the established deadlines will result in forfeiture of the position of winner, whatever the cause.

ART. 12 - SCROLLS IN THE RANKING LIST.

If, after the deadline for enrollment, there are vacancies, they will be filled by means of the publication of rankings, in a maximum number of three, which will be carried out according to the calendar indicated in the following art. 13, according to the procedures referred to in the previous art. 5 of this announcement.

If within the peremptory term of the third scrolling of the ranking referred to in the following art. 13 places are available, as part of the ranking reserved for non-EU candidates residing abroad, they will be used in accordance with the provisions of art. 2, paragraph 2, of the D.M. n. 733/2021.

No further ranking lists will be published beyond those indicated above, unless otherwise justified. The lists of those entitled to enrollment by scrolling will be published on the University website, at www.unicampania.it.

The publication has the value of official notification to interested parties for all legal purposes and, therefore, no communications and personal notifications will be sent to candidates.

Failure to register by those entitled within the terms provided above will result in forfeiture of the right to enroll in the A.Y. 2021/2022 to the degree course covered by this announcement.

ART. 14 - CANDIDATES IN SITUATION OF HANDICAP AND / OR AFFECTED BY D.S.A.

1. Candidates with disabilities, in application of art. 16 and 20 of the law 05/02/1992 n.104, as modified by the law 28/01/1999, n. 17, may require the necessary aids, in relation to the type of disability and degree, as well as the possible granting of additional time for carrying out the test. Candidates themselves are entitled to an additional time not exceeding 50% more than that foreseen for carrying out the test referred to in this notice of competition.



- **2.** Candidates with a certificate of disability or with certification pursuant to Law 104/1992, must promptly submit to the University, for the purpose of organizing the test, the original or certified copy of certification on plain paper, issued by the Commission. competent doctor for the territory proving the type of disability and / or the degree of disability recognized.
- **3.** Candidates diagnosed with specific learning disorders (SLD), certified in accordance with law no. 170/2010 mentioned in the introduction, must present appropriate certification issued no more than 3 years ago, or after the eighteenth year of life, by Local Health Facilities or by Bodies and Professionals accredited with the S.S.N.

These candidates are granted an additional time equal to 30% more than that defined for the admission tests.

- **4.** Candidates with invalidity, disability or SLD resident in foreign countries, who intend to take advantage of the measures referred to in the preceding paragraphs, must submit certification certifying the state of invalidity, disability or SLD issued in the country of residence, accompanied by a translation sworn, in Italian or in English. The Bodies of this University, in charge of examining the certifications referred to in the preceding paragraphs, ascertain that the foreign documentation certifies a condition of invalidity, disability or specific learning disability recognized by Italian law.

- **6.** In order to ensure equal opportunities in carrying out the tests, the University allows the use of compensatory instruments in accordance with the provisions of art. 9, paragraph 4 letter b of the D.M. n. 730 of 25.06.2021 referred to in the introduction.
- **7.** The candidates referred to in paragraphs 2 and 3 above may be admitted to the test with the medical certification they possess, even if not updated due to the limitation of the activity of the SSN for the COVID-19 emergency, subject by the universities to subsequently request the integration of the documentation provided therein.

Applications submitted in deviation from the provisions of this article will not be taken into consideration.
