**CALL FOR APPLICATIONS FOR ADMISSION TO THE
THREE-YEAR DEGREE COURSE IN
--- NURSING ---
A. Y. 2024/2025**

ART. 1 – CALL FOR APPLICATIONS AND AVAILABLE PLACES.

The competition, by exam, for admission to the three-year degree course in Nursing, set up and activated at the Università degli Studi della Campania “Luigi Vanvitelli”, for the A.Y. 2024/2025, is announced, for a provisional total **number of places equal to 20 (twenty)** divided as follows:

- a) 10 places** intended exclusively for EU citizens and non-EU citizens pursuant to art. 39 co. 5 of Legislative Decree no. N. 286/1998, as amended by art. 26 of Law no. 189 of 2002;
- b) 10 places** reserved for non-EU students residing abroad.

With a subsequent provision, the quantification and final distribution of the posts - also in decrease with respect to the scheme referred to in this article - will be announced, subject to the determinations made by the Campania Region in this regard.

ART. 2 - REQUIREMENTS FOR ADMISSION.

EU candidates and non-EU candidates residing in Italy, referred to in art. 26 of Law no. 189 of 2002¹ mentioned in the introduction, in possession of a second-level secondary school diploma, lasting at least four years, or equivalent qualification, as well as all those who will achieve this high school diploma within the school year, can produce an application for participation in the competition - for access to **n. 10 positions referred to in letter a)** of the previous article.

Only non-EU citizens residing abroad who have complied with the inter-ministerial provisions relating to the procedures for the entry, stay and enrollment of foreign/international students on higher education courses in Italy for the A.Y. 2024/2025, published on the **MUR website** at www.mur.gov.it, can participate in the selection for the **10 places referred to in letter b)** of the previous article.

ART. 3 - METHOD OF PARTICIPATION IN THE COMPETITION.

To be admitted to the competition, candidates competing for the **10 (ten) places intended exclusively for EU citizens and non-EU citizens pursuant to art. 39 co. 5 of Legislative Decree no. 286/1998, as amended by art. 26 of Law no. 189 of 2002**, must submit an application to participate, using the credentials to access the University web services, exclusively via an IT procedure (*site: www.unicampania.it – [Servizi per Studenti](#) > [Concorsi on-line](#) - click on > [ACCEDI](#) and, once you have chosen the competition you wish to participate in, select **category 995**), as from the day following publication of this notice and no later than **03 September 2024**.*

To be admitted to the competition, candidates competing for the **10 (ten) places intended exclusively for non-EU citizens residing abroad** must submit an application to participate, using the credentials to access the University web services, exclusively via the IT procedure (*site: www.unicampania.it – [Servizi per Studenti](#) > [Concorsi on-line](#) - click on > [ACCEDI](#) and, once you have chosen the competition you wish to participate in, select **category 997**), as from the day following publication of this notice and no later than **03 September 2024**.*

For users who do not have credentials, it is necessary to acquire them through the registration procedure described in the "[Guide for registering for University web services](#)".

To participate in the competition, candidates are required, under penalty of exclusion, to pay a contribution of €100,00 to be made – following the creation of the Pago-PA Notice in the IT procedure – by **03/09/2024**.

¹ Foreigners holding a residence card or a residence permit for employment or self-employment, for family reasons, for political asylum, for humanitarian asylum, or for religious reasons, or foreigners legally residing for at least one year in possession of a higher education qualification obtained in Italy, as well as foreigners, wherever resident, who hold final diplomas from Italian schools abroad or foreign or international schools, operating in Italy or abroad, subject to bilateral agreements or special regulations for the recognition of educational qualifications and who meet the general conditions required for entry for study purposes.

This payment can be made through both physical and online channels of banks and other Payment Service Providers (PSP), such as bank agencies, home banking, ATMs, SISAL, Lottomatica and Banca 5 points of sale, using the Pago-PA Payment Notice, which will be generated as part of the aforementioned IT procedure for registering for the competition.

The IT procedure for submitting applications will be deactivated, strictly and automatically, on **03 September 2024** and, therefore, after this deadline it will no longer be possible to fill in the application for participation in the competition and generate the Notice of payment Pago PA bank to be used for the payment of the contribution for participation in the competition.

Registration for the competition is to be considered concluded only after payment of the aforementioned contribution has been made, within the terms and in the manner indicated above.

This payment will in no case be refunded and is valid exclusively for the competition for which the application form is being submitted.

The application submission procedure can be carried out - 24 hours a day - from any computer connected to the network.

Failure to submit the application within the aforementioned terms and in the manner indicated precludes any possibility of access to the competition.

The Administration, at each stage of the procedure, reserves the right to ascertain the truthfulness of the substitute declarations of certification or notarial deeds made by the candidates, in accordance with current legislation on the subject; the candidate, therefore, must provide all the necessary elements to allow the Administration to carry out the appropriate checks.

All candidates are admitted with reserve to the procedure set out in this notice of competition.

The Administration, with a reasoned decree, may proceed, at any time, to the exclusion of the candidate from the competition for lack of the prescribed requirements.

ART. 4 - ADMISSION TEST: DATE AND PLACE.

1. The admission test to the three-year Degree Course in Nursing is set for **09 September 2024, starting at 11.00**. The test will last **100 (one hundred) minutes**.

The venue for the competition test will be announced with a subsequent notice, published on the University website, at the address www.unicampania.it. The participants in the competition test will be distributed by age, except for twins.

2. Candidates must present themselves **at the venue for the competition test at 09.00 am**, with a valid identification document, the receipt of the application form and the original receipt of payment of the participation fee, to be shown in order to complete the necessary identification procedure.

3. Candidates without an identification document will not be admitted participating in the competition test, unless they are presented with a regular report of loss or theft produced to the competent authorities.

4. Candidates without the receipt of the submission of the application for registration, or the original receipt of payment of the participation fee, will not be admitted to take the test unless they are present in the lists of those entitled, prepared by the University.

5. Access to the test is not permitted for candidates who present themselves after the closure of the recognition operations.

6. Candidates who, for any reason, are absent from the test, after the closure of the aforementioned recognition operations, are considered to have renounced participation in the competition referred to in this announcement.

The above has the value of official notification.

ART. 5 - ADMISSION TEST: CONTENTS - CRITERIA FOR EVALUATION - TIME ALLOCATED FOR PERFORMANCE.

1. The admission test, which is attended by both EU and non-EU students pursuant to art. 26 of Law no. 189 of 2002, both non-EU citizens residing abroad, is unique and will be prepared by CINECA on behalf of the University.

2. The aforementioned test consists in the solution of n. 60 questions in English with five answer options, of which the candidate must identify only one, discarding the wrong conclusions, arbitrary or less

probable, on the following topics: reading skills and knowledge acquired in studies (4 questions), logical reasoning and problems (5 questions), biology (23 questions), chemistry (15 questions), physics and mathematics (13 questions), on the basis of the program referred to in attachment "A" of the Ministerial Decree of 31 July 2024 no. 1116.

3. For the evaluation of the admission test a maximum of 90 (ninety) points are awarded and the following evaluation criteria are taken into account:

- a) 1.5 points for each correct answer;
- b) minus 0.4 (- 0.4) points for each wrong answer;
- c) 0 points for each answer not given.

On the basis of the score, calculated as provided in this article, two merit lists will be drawn up; one list for EU and non-EU candidates resident in Italy, and one list for non-EU candidates resident abroad.

On the basis of the score, calculated as required by this article, the general merit ranking will be drawn up.

- In the event of a tie, the score obtained by the candidate in the solution, respectively, of the questions relating to the topics of biology, chemistry, physics and mathematics, logical reasoning and reading skills and knowledge acquired in the studies, prevails in descending order.

- In the event of a tie between one or more disabled candidates in possession of a certificate of disability equal to or greater than 66% or disabled with certification pursuant to law no. 104 of 1992 art. 3, paragraph 3, and one or more candidates not falling within the aforementioned categories, the invalid candidate (s) in possession of a certificate of invalidity equal to or greater than 66% or disabled with certification pursuant to law no. 104 of 1992 art. 3, paragraph 3.

The disabled candidate with a certificate of disability equal to or greater than 66% or the disabled candidate with certification pursuant to Law no. 104 of 1992 art. 3, paragraph 3 in possession of medical certification, even if not up-to-date due to the limitation of the activities of the SSN for the covid-19 emergency, who intends, in the event of a tie with another candidate who does not fall into the above categories, to assert this preference is required to present to the University where he/she was "assigned" within the peremptory term of 15 (fifteen) days from the assignment, including the first day, the certificate of disability equal to or greater than 66% or the certification pursuant to Law n. 104 of 1992 art. 3, paragraph 3, under penalty of exclusion from the national ranking list.

Once this deadline has expired in vain, the undocumented preference title cannot be taken into account.

- Apart from the above, in the event of a further tie, the candidate with the youngest age prevails.

The admission test will also be completed if the number of applications presented is equal to or less than the number of places available.

ART. 6 - ADMISSION TEST: PROCEDURE - CANDIDATES' OBLIGATIONS - SUPERVISION.

1. At the time of the test, each candidate is given an envelope prepared by CINECA on behalf of the University.

Each package contains:

- a) a personal data sheet, without any identification code, which the candidate must fill in;
- b) the questions relating to the admission test, bearing the identification code of the package as well as n. 2 sheets dedicated to draft;
- c) a reply form, with the same identification code as the package;
- d) a sheet on which the identification code of the package is affixed as well as the indication of the University and the degree course to which the test refers;
- e) a sheet containing the anonymous credentials (User-ID and Password) through which the Candidate, after correcting the test, will be able to access a web page - corresponding to a URL (also present on the sheet) - where he can view :
 1. his proof, in .html format, with an indication of the correct answers he should have provided;
 2. the score obtained;
 3. the scan of your reply form.

The replacement that may become necessary during the test, even of only one of the documents indicated in points b), c) and e) entails the complete replacement of the package, as they are distinguished by the same identification code of the package.

Any corrections or signs made by the candidate on the personal data sheet do not entail its replacement. The replacement of the personal data sheet is provided only where the signs or corrections made by the candidate involve an objective difficulty in identifying the candidate: in that case, the Commission will replace the personal data sheet by taking it from one of the reserve packages and the operation will acknowledge in the classroom minutes. **The replacement of the personal data sheet never involves the replacement of the entire envelope.**

Before the start of the test, the President of the Examination Commission or the Classroom Manager draws four students from among the candidates present in the classroom and checks with them the integrity of the boxes, then opens them and distributes the packages in relation to the number of participants; gives each candidate the "*instruction sheet for completing the answer form*".

The "*instruction sheets for completing the answer form*" are made available to candidates before the test is carried out. The President of the Examination Committee or the Head of the classroom draws up and signs, for the operations carried out above, a specific declaration - **CLASSROOM REPORT** - which show:

- 1.1) the verification of the integrity of the boxes;
- 1.2) the number of packages assigned;
- 1.3) the number of packages that may not have been used;

This declaration must also be signed by the four students drawn for the verification of the integrity of the packages containing the competition material.

In the event that one or more candidates report any irregularities regarding the package received, the President of the Examination Commission or the Head of the classroom checks its reliability and, if necessary, replaces the package itself. This operation must appear in the classroom minutes together with the related reasons. The replaced packages are not to be considered waste material but must be kept by the University.

Candidates, to fill in the answer form, must use only an indelible black pen, supplied by this University and must mark the chosen answer by putting the X sign in the corresponding box. It is possible to correct once and only once the answer that may have already been given to a question, taking care to completely black out the box previously drawn and choosing another: in any case, there must be a mark (X) in only one of the five boxes because the relative score can be attributed.

The answer form provides, in correspondence with the progressive number of each question, a small circular figure that the student must cross only if he intends to give certainty of the will not to answer. This indication, once affixed, can no longer be changed; if the candidate does not put any sign in the answer boxes, even if he does not tick the circular figure, the answer is considered not given.

On the answer form - for the purpose of determining the relative score - there must be no signature or any identification mark, under penalty of cancellation of the test.

At the end of the test, the candidate is invited to reach a dedicated station equipped with a special pen, prepared by the Commission and placed at a suitable distance from it, and is invited to choose a pair of identical adhesive labels present therein. Each label must be applied, exclusively by the candidate, who must ensure that the alphanumeric codes printed on the labels of the chosen pair, on the answer form and on the personal data sheet correspond. The candidate must therefore obligatorily sign, on the duly completed personal data sheet, the declaration of truthfulness of the personal data and correspondence of the codes of the labels applied to the personal data sheet and to the answer form. At the end of these operations, the candidate must insert the personal data sheet in the sealed container present in the dedicated station and go to another dedicated station where he inserts the answer form in the closed container provided therein, taking care to insert the front of the form, containing the answers provided by the candidate, face down, facing down.

In addition to the answer form and the personal data sheet, the candidate must return to the Commission all the residual material contained in the package delivered at the beginning of the test.

The President of the Commission or the Head of the classroom then provides:

- to count the answer forms and to insert them in one or more containers that must be closed in the presence of the same candidates called to verify the integrity of the boxes or, in the event of their impossibility, in the presence of four other candidates drawn by lot;

- to insert all the personal data sheets in one or more containers that must be closed in the presence of the same candidates called to verify the integrity of the boxes or, in the event of their impossibility, in the presence of four other candidates drawn by lot;
- to affix a signature on the closing flaps of the containers and to invite the four students to put their signature on the same flaps;
- to pack other containers in which to enclose the packages returned because they have been replaced, the packages from which the personal data sheets for replacement have been taken as well as the unused packages, the declaration referred to in this article and a copy of the classroom report, with the classroom lists of candidates.

2. Candidates are prohibited from keeping with them, during the tests, bags or backpacks, books or notes, paper, personal tools suitable for writing (pens, pencils, etc.), mobile phones, "smartphones" and other electronic tools, including "smartwatches", "PDAs", tablets, headsets, webcams and portable personal computers of any type able to connect outside the classrooms, test locations, via "wireless" connections, or to the normal telephone network with UMTS, GPRS, GSM protocols, under penalty of cancellation of the test. Therefore, candidates are prohibited from introducing within the competition venue: mobile phones, smartphones, smartwatches, PDAs, tablets, headsets, webcams and other similar tools; Candidates, who are in possession of such equipment, must deliver them to the identification staff before entering the classroom or sector where the candidate was assigned to perform the test.

It is also forbidden to introduce manuals, school texts, handwritten notes and reference material and blank sheets. During the test, competitors are not allowed to communicate verbally or in writing, or to relate to others, except with the members of the Commission or the Supervisory Committee or with the technical-administrative staff responsible for surveillance.

ART. 7 - CAUSES FOR CANCELLATION OF THE TEST FOR A CANDIDATE.

The following are grounds for cancellation of the test:

- 1.** the performance of the test by the candidate in an exam room other than the one in which the candidate is enrolled in the room lists unless the variation has been authorized by the Examination Commission and this is acknowledged in the report;
- 2.** the introduction and use in the classroom, by the candidate, of mobile phones, PDAs, smartphones, smartwatches, tablets, headsets, webcams or other similar equipment, manuals, school texts and / or even partial reproductions of them, handwritten notes and reference material, as already provided for in paragraph 2 of article 6 of this announcement;
- 3.** the affixing on the response form (both on the front and on the back) of the signature or marks of the candidate or a member of the Commission;
- 4.** the interaction between candidates and / or attempts to copy and / or attempts to exchange any material, including the exchange of personal data and / or response forms, in the possession of the candidates;
- 5.** the use by the candidate, during the operations of inserting the personal data sheet and the answer form inside the containers used therein, of pens, pencils or any other suitable instrument for writing in order to make changes, additions and / or corrections to the reply form.

The cancellation of the test is ordered by the Commission. In the cases referred to in numbers 1), 2), 3) 4) and 5) the CINECA does not determine the score of the cancelled test.

The test is also subject to cancellation in case of use by the candidate, after the end of the test, of pens, pencils or any other suitable writing instrument in order to make changes, additions and / or corrections to the answer form, and in the event that the personal data sheet shows deletions and / or abrasions or indicates data which, at the discretion of the Commission, do not allow the author of the paper to be traced with certainty.

ART. 8 - CRITERIA AND PROCEDURES FOR THE APPOINTMENT OF THE COMMISSION IN CHARGE OF THE ADMISSION TEST AND FOR THE APPOINTMENT OF THE PROCEDURE MANAGER.

The Commission in charge of the admission test, appointed with a subsequent provision, is composed of the President, a teacher with teaching activities in the study courses of the School of

Medicine and Surgery and of 4 (four) effective members plus two alternates, appointed from among all the teachers and researchers with teaching activities in the study courses of the School of Medicine and Surgery. The Commission is given all responsibility for the regular performance of the test in question, according to the methods and criteria set out in this announcement and by the Ministerial Decree of the M.U.R. of 31/07/2024 n. 1116 mentioned in the introduction. The commission in charge of the test is also responsible for the tasks that will be detailed in the appointment provision. All the operations carried out by the Commission in charge of the test must be reported in a special report, initialed on each sheet and signed by the President and by all the members of the commission itself.

During the test, the aforementioned Commission is assisted in its tasks by a Supervisory Committee - also appointed with a subsequent provision - made up of teaching and / or research staff with teaching activities in the study courses of the School of Medicine and Surgery, with tasks of checking the regularity of the performance of the test and reporting any irregularities to the Commission, which will take the relevant decisions.

In the supervisory activity, the Commission will be supported not only by the aforementioned Supervisory Committee, but also by the University's technical-administrative staff in charge of this function, as well as by security guards.

Pursuant to art. 4 of the law n. 241 of 07/08/1990 and subsequent amendments (new rules on administrative procedure and right of access to administrative documents) and Single regulation on transparency: discipline on administrative procedure and access (D.R.n.622 of 26.07.2018) is appointed Head of the entire insolvency procedure, which is the responsibility of the Commission of selection, Dr. Sonia VISCUSI, category D, economic position D3, Head of the Office of the Secretariat of Medicine and Surgery Students at Caserta.

The members of the Commission and the Supervisory Committee, the Head of the procedure and all the staff involved in any capacity in the supervisory operations, before carrying out the admission test referred to in this announcement, must, after consulting the printouts showing the names of the candidates admitted to participate in the competition, issue a declaration that they have no kinship or affinity relationship with any of them up to and including the fourth degree, that they do not hold political positions.

ART. 9 – RANKING.

Candidates are only eligible if they have obtained a score greater than zero (0) points; candidates who have not provided any answer to any question are not included in the ranking.

Based on the evaluation criteria referred to in art. 5 of this call for applications, the University draws up two distinct rankings, one for EU citizens wherever they reside and non-EU citizens pursuant to art. 26 of Law 189/2002, and the other for non-EU citizens residing abroad.

In both merit rankings, the winners will be those who place themselves in the best positions, respecting the number of places available.

A candidate that fails to place in one of the available places is not entitled to enrollment, without prejudice to any changes in the ranking specified in the following art. 12.

ART. 10 - PUBLICATION OF RANKINGS.

The rankings will be published in the [dedicated section of the University website](#) by **20 September 2024**.

The publication has the value of official notification to interested parties for all legal purposes and, therefore, no communications and personal notifications will be sent to candidates.

ART. 11 - TERMS TO BE OBSERVED FOR ENROLLMENT.

Candidates who compete for the quota reserved for EU citizens and non-EU citizens residing in Italy, as referred to in Article 39, par. 5, legislative decree n. 286 of 07/25/1998, as amended by art. 26 of the law n. 189 of 2002 - taking into account the number of places in the competition referred to in art. 1 of this announcement - must register and submit the enrollment application exclusively in the manner indicated below, starting from 24 September 2024 at 9.00 and no later than 12.00 on 03 October 2024:

Register and submit the enrollment application online, by accessing the student web services area on the [Enrollment online page](#) with the credentials already used, according to the procedures

indicated in the [Enrollment Guide for courses with set number](#), indicating as Course Type "Bachelor's Degree" (*Laurea Triennale*) and as study courses the course codes shown in the table referred to in the previous art. 1 of this call for applications B50 – CdL in Nursing.

Note that at the same time as the payment of the first enrolment instalment, payment of the regional tax for the right to study is expected, exclusively through the online services of Adisurc (Azienda per il diritto allo Studio della Regione Campania) by connecting to the website www.adisurcampania.it and accessing the following page: https://www.adisurcampania.it/pagina1103_pagopa.html.

Please note that payment of the regional tax at the same time as the first enrolment instalment is a necessary condition for finalising enrolment.

During the ONLINE REGISTRATION procedure of the enrolment application, it is necessary to upload the following documentation:

The following documents must be uploaded during the ONLINE REGISTRATION procedure of the registration application

- identity document (mandatory and blocking upload)
- tax code (mandatory and blocking upload);
- passport-size photo (at least 266x354 pixels) showing your face in close-up (mandatory, non-blocking upload, to be carried out in any case within 30 days after registration of the application).

During the ONLINE SUBMISSION procedure of the enrolment application, it is necessary to upload the following documentation, in the users web area in the "Career / Career Attachments" section:

- enrolment application previously registered, printed and signed (Type of attachment: *Enrolment application*);
- receipt of payment of the first enrolment fee (Type of attachment: *Receipt of payment of the first enrolment fee*).
- Regional Tax Payment Receipt (Type of Attachment: Regional Tax Payment Receipt)

The enrolment application will be considered to have been duly submitted only if, within the enrolment deadlines, the aforementioned uploads are present in the aforementioned computer procedure - (identification document, tax code, signed enrolment application and receipt of payment of the enrolment instalment or virtual stamp and telematic receipt of payment of the regional tax). Failure to comply with the above will result in the loss of the right to enrolment.

The exact date and time of upload is recorded in the University database, therefore uploads made after the indicated deadline will not be valid for enrolment.

Applications or documentation sent by post, PEC or fax will not be accepted.

Failure to register within the established deadlines will result in forfeiture of the position of winner, whatever the cause.

ART. 12 - SCROLLS IN THE RANKING LIST.

Should vacancies arise after the deadline for enrolment, they will be filled through the publication of sliding rankings, up to a maximum number of three.

If, after the deadline for enrolment, vacancies are found, the Health Professions CdI Student Secretariat Office will proceed with the scrolling of the general merit list.

In particular, on 09 October 2024, the Registrar's Office will publish the list of those entitled to enrolment following the first sliding of the rank list.

Those entitled to enrolment, following the aforementioned re-scrolling, must complete the enrolment process starting from 09.00 on 10 October 2024, and no later than 12.00 on 15 October 2024, in accordance with the procedures set out in the previous article.

If, at the end of the period allowed for the registration of those entitled to enrol following the first screening, there are still unfilled places, the second screening of the rank list will take place.

Therefore, on 18 October 2024, the Registrar's Office will publish the list of those eligible for enrolment following the second ranking.

Those entitled to enrol, following the aforementioned shortlisting, must complete the enrolment process starting from 09.00 on 21 October 2024, and no later than 12.00 on 24 October 2024, in the manner and according to the procedures set out in the previous article.

If, at the end of the period allowed for the registration of those entitled to enrol following the second scrolling, there are still unfilled places, the 3rd scrolling of the rank list will take place.

On 29 October 2024, the Registrar's Office will publish the list of those eligible for enrolment following the 3rd sliding of the rank list.

Those entitled to enrol, following the aforementioned re-ranking, must complete the enrolment process starting from 09.00 a.m. on 30 October 2024, and no later than 12.00 noon on 31 October 2024, in accordance with the procedures set out in the previous article.

In the event that at the end of the 3 foreseen shortlistings there are still unfilled places, this Administration, with justified measure, reserves the right to publish subsequent rankings.

Should the ranking of EU and non-EU citizens residing in Italy, as per art. 26 of Law 189/2002, be exhausted by the deadline of the third round, due to a lack of beneficiaries, the places not filled will be allocated to non-EU citizens residing abroad, until they are completely filled.
Should the ranking of non-EU citizens residing abroad be exhausted by the peremptory deadline of the third screening due to a lack of beneficiaries, the places not filled will be allocated to EU and non-EU citizens residing in Italy, as per art. 26 of Law 189/2002, until they are completely filled.

Once all the shortfalls provided for in this article have been completed, and if there are still places available due to a lack of beneficiaries, this University will apply the provisions of art. 6, paragraphs 6 and following, of Ministerial Decree no. 1116 of 31.07.2024.

The lists of those entitled to enrolment by sliding scale will be published on the University's website at www.unicampania.it.
The publication has the value of official notification to the interested parties for all legal purposes and, therefore, no personal communications or notifications will be sent to the candidates.

Failure to enrol those entitled to do so by the aforementioned deadlines shall result in forfeiture of the right to enrol in the A.A. 2024/2025-degree course that is the subject of this call for applications.

ART. 13 - CANDIDATES WITH DISABILITIES AND/OR WITH S.L.D.

1. In accordance with Articles 16 and 20 of Law no. 104 of 05/02/1992, as amended by Law no. 17 of 28/01/1999, disabled candidates may request the necessary aids, depending on the type and degree of their disability, as well as any additional time they may need to take the test. The candidates themselves are entitled to additional time not exceeding 50% over and above the time set aside for the performance of the test referred to in this notice of competition.
2. Candidates with a certificate of disability or certification pursuant to Law 104/1992 must promptly submit to the University, for the purposes of the organisation of the test, the original certification or a certified copy on plain paper, issued by the competent medical commission for the area, proving the type of disability and/or the degree of recognised handicap.
3. Candidates with a diagnosis of specific learning disabilities (S.L.D.), certified in accordance with law no. 170/2010 cited above, must present suitable certification issued no more than three years

previously, or after their 18th birthday, by Local Health Authorities or by Bodies and Professionals accredited with the National Health Service.

4. These candidates are granted additional time equal to 30% more than that defined for the admission tests.
5. Applicants with a disability, invalidity or S.L.D. residing in foreign countries, who intend to take advantage of the measures referred to in the previous paragraphs, must present certification attesting to their state of invalidity, disability or S.L.D. issued in their country of residence, accompanied by a sworn translation, in Italian or English. The Bodies of this University, in charge of examining the certifications referred to in the preceding paragraphs, shall ascertain that the foreign documentation certifies a condition of invalidity, disability or specific learning disorder recognised by Italian law.
6. The application for the necessary aids as well as the possible concession of additional time, must be submitted, with attached suitable medical documentation as per paragraphs 2, 3 and 4 above, by the expiry date of the notice of competition, to the Head of Procedure Dr. Sonia VISCUSI, by registered mail with return receipt addressed to the aforementioned "Head of Procedure of the competition for admission to the three-year degree course in Nursing (Nursing in English language) - A. A. 2024/2025 - c/o UFFICIO ARCHIVIO E PROTOCOL - UNIVERSIVERSITY OF THE STUDIES OF CAMPANIA "LUIGI VANVITELLI" - P. PANVITELLI - P. P. P. Requests received by PEC with the name of the holder of the PEC different from that of the candidate concerned will not be evaluated.
7. In order to guarantee equal opportunities in the performance of the tests, the University allows the use of compensatory instruments in accordance with Article 5 of Ministerial Decree no. 1116 of 31/07/2024 referred to in the introduction.
8. The candidates referred to in paragraphs 2 and 3 above may be admitted to the test with the medical certification they possess, even if not up-to-date due to the limitation of NHS activity for the COVID-19 emergency, subject to the Universities' right to request the integration of the documentation provided therein at a later date.

Applications submitted in contravention of this Article will not be considered

ART. 14 - PROCESSING OF PERSONAL DATA

Pursuant to Articles 13 and 14 of the GDPR - EU General Data Protection Regulation no. 2016/679, the personal data provided by candidates will be collected at the Università degli Studi della Campania "Luigi Vanvitelli", for the purposes of managing the selection and will be processed on paper and through an automated database.
